

GRADING SYSTEM FOR PERMANENT MAKEUP COURSES

At The Perfect Arch Permanent Makeup & Training Institute, we believe in a comprehensive grading system that accurately reflects students' mastery of both theoretical knowledge and practical skills in the field of permanent makeup. Our grading system is designed to encourage continuous learning, skill development, and a thorough understanding of the subject matter.

1. Written Assessments:

Written assessments evaluate students' understanding of theoretical concepts, color theory, safety protocols, and client consultation techniques. These assessments may include multiple-choice questions, short answers, and essays. Each assessment is assigned a numerical value, and the cumulative score contributes to the overall grade.

2. Practical Application:

Practical assessments gauge students' hands-on skills in performing various permanent makeup procedures. Students will be evaluated on aspects such as technique precision, symmetry, pigment application, and client communication. Practical assessments are typically conducted on live models in a controlled environment.

3. Assignments and Projects:

Assignments and projects are assigned to reinforce understanding and practical application. These could include tasks such as creating simulated treatment plans, analyzing case studies, or developing marketing strategies for a permanent makeup business. Assignments are graded based on creativity, accuracy, and adherence to guidelines.

GRADING SCALE

Our institute employs a grading scale that helps students understand their performance relative to the course objectives. The grading scale may be as follows:

A (90-100%):

Outstanding performance, demonstrating mastery of concepts and exceptional practical skills.

B (80-89%):

Above-average performance, with a strong grasp of concepts and competent practical skills.

C (70-79%):

Satisfactory performance, indicating an adequate understanding of concepts and acceptable practical skills.

D (60-69%):

Below-average performance, with some gaps in understanding and practical execution.

F (Below 60%):

Unsatisfactory performance, suggesting insufficient understanding of concepts and poor practical skills.

Final Grade Calculation:

Final grades are usually calculated by weighing different components of assessment. For instance:

Written Assessments: **30%**

Assignments and Projects: 15%

Practical Application: 40%

Attendance and Participation: 15%

SATISFACTORY ACADEMIC PROGRESS (SAP) POLICY

The Satisfactory Academic Progress (SAP) Policy is consistently applied to all students enrolled at The Perfect Arch. To be in good academic standing, and to be considered making SAP, all students must earn a minimum cumulative grade of 80% in all coursework and attendance.

Evaluation Periods for Permanent Cosmetics

- 200 hours = evaluation period
- 400 hours total program clock hours / evaluation period

Evaluation Periods Advance Permanent Cosmetics

- 200 hours = evaluation period
- 600 hours = total program clock hours / evaluation period

The maximum time frame to complete the programs is 9 months. Penalties could incur after contract date. Students who do not complete the program within 9 months will be terminated and may re-enroll on a cash-pay basis. Course incomplete, repetitions and no-credit remedial courses are not offered at this institution, therefore they have no effect upon the school's SAP standards.

*Transfer hours from another institution that are accepted toward the student's educational program are counted as both attempted and completed hours for the purpose of determining when the allowable maximum time-frame has been exhausted. SAP evaluation periods will be based on the actual contracted hours at this institution. Evaluations determine if the student has met the minimum requirements for satisfactory academic progress. Students will be notified if they are not meeting the minimum requirements for satisfactory academic progress. Students satisfactory academic progress evaluation results will be kept in the students file and students can access their results upon request.

PROGRESS POLICY FOR VA STUDENTS

Evaluation of progress of VA students will be conducted by the school's evaluation policy schedule. Students with a minimum of 70 % academic average and 75% attendance will be considered making satisfactory progress until the next scheduled evaluation. In order for a student to be considered making satisfactory progress the student must meet both attendance and academic minimum requirements. Students receiving VA benefits who fail to meet minimum progress and attendance requirements will be placed on probation for 30 days. At the end of the probationary period, the

the student's progress (academic and attendance) will be reevaluated. If the student is meeting minimum requirements, the student will be determined to be making satisfactory progress and will be considered off Probation. If you fail to maintain satisfactory progress you may no longer be eligible for benefits.

ACADEMIC PROGRESS

Grades are given for bookwork theory and practical work, projects and lab performance. The grading criteria utilized is a reasonable system used to evaluate students. The following percentage system for letter grade assignment will be utilized for reporting grades:

If a student is determined as NOT making Satisfactory Progress, the student may appeal the negative determination. Students may appeal for reasons such as death of a relative, injury/illness of the student, or other extenuating circumstances. The student must submit a written appeal on the school's form to the school administration within 5 days of the determination, with supporting documentation regarding why the student failed to make SAP and what has changed in the student's situation that will allow the achievement of SAP at the next evaluation. An appeal hearing will take place within five (5) business days of receipt of this written appeal. This hearing will be attended by the student, parent/ guardian if applicable, and appropriate school staff. A decision on the appeal will be made within three (3) business days after this hearing, and will be communicated in writing. This decision will be final and documentation will be placed in the student's file. Students who prevail upon appeal will have eligibility for any on hold benefits to be reinstated and be placed on a Probation Status.

ACADEMIC PROBATION AND SUSPENSION

All students attending The Perfect Arch are expected to make satisfactory academic progress (SAP) in all attempted courses. To be in good academic standing, all students must earn a minimum cumulative

grade of 80% in all coursework. Students who fail to meet these standards will be on academic probation for one month. If these students do not achieve the minimum cumulative grade of 80% at the end of the probationary period, they will be suspended until the end of the following month. Readmission is not automatic; each case will be judged on a case-by-case basis.

The school may allow for the status of probation for students who are not considered meeting the minimum standards for satisfactory progress if: The Institution evaluates the student's progress and determines that the student did not make satisfactory academic progress during the warning or previous evaluation period and the student prevails upon appeal of a negative progress determination prior to being placed on probation. The school will also determine if satisfactory academic progress standards can be met by the end of the subsequent evaluation period and will develop an academic plan for the student that, if followed, will ensure that the student is able to meet the SAP requirements by a specific point within the time frame established for the individual student.

Students may reestablish SAP by making up missed assignments and increasing grade average to 80% or better and/or increasing cumulative attendance to 80%.

RE-ENTERING STUDENT

Acceptance to The Perfect Arch is contingent on course offering, space availability, and the scheduling of an appointment with the Program Director for advising, possible theory remediation, and any diagnostic or skills testing as required. The student will be notified in writing if reinstated in the program. Re-entering students will enter in the same progress status as when they left. The student will be required to purchase any textbooks, supplemental material, or supplies required. Discipline issues will require the student to wait for one full course before reinstatement is granted. Possible counseling may be required based on individual circumstances.

4. Refund Policy:

For applicants who cancel enrollment or students who withdraw from enrollment a fair and equitable settlement will apply. The following policy will apply to all terminations for any reason, by either party, including but not limited to student decision, course or program cancellation, or school closure. Any monies due the applicant or students shall be refunded within 45 days of official cancellation or withdrawal.

A. All fees and payments, except the non-refundable application fee, remitted to the school by a prospective student shall be refunded if the student does not enroll in the school, does not begin the program or course, with-draws 3 days prior to the start of the program, or is dismissed prior to the start of the program. Applicants who have not been accepted for admission will be notified via an emailed denial letter.

B. The school shall provide a period of at least two business days, exclud-ing weekends and holidays, during which a student applicant may cancel his enrollment without financial obligation other than the nonre-fundable application fee.

C. Following the period described in section 2 above, a student applicant (who has applied for admission) may cancel, by written notice, his enrollment at least 3 days prior to the first class day of the session for which application was made. When cancellation is requested under these circumstances, the school is required to refund all tuition paid by the student less the nonrefundable application fee. A student applicant will be considered a student as of the first day of classes.

D. The date of the institution's determination that the student withdrew should be no later than 14 calendar days after the student's last date of attendance as determined by the institution from its attendance records. After 14 calendar days, the institution is expected to have determined whether the student intends to return to classes or to withdraw. In addi-tion, if the student is eventually determined to have withdrawn, the end of the 14-day period begins the timeframe for calculating the refunds. In the event that a written notice is submitted, the effective date of termi-nation shall be the date of the written notice. The school may require that written notice be transmitted via registered or certified mail, or by elec-tronic transmission, or in writing per the Refund Policy in the enrollment contract.

The school is required to submit refunds to individuals who have terminated their status as students and are due a refund per the institutional Refund Policy, within 45 days after receipt of a written request or the date the student last attended classes whichever is sooner.
